Proposed Subscriptions for 2024

We are asking members to support the Trustees' recommendation to increase the subscription fees for 2024.

As members will know, the economic crisis has been hard on everyone and small organisations like the RCOphth are not immune to the effect of increases in running our services and maintaining our head office.

We continue to carry out our charter and our purpose to serve members and to set the standards of eye care and to support the professional development, training, examinations and education of those who care for ophthalmic patients. These services incur staffing, travel and meeting costs, including supporting members who volunteer in many roles to support this work.

We are also working more closely and widely with the National Clinical Director for Eyecare and bodies like NHS England, Wales and the Scottish equivalent, advocating for stronger investment in the ophthalmic workforce and infrastructure.

We continue to make efficiencies, where we can, to reduce rising inflation and for the long-term sustainability of the College and its services, including finding other income streams to support our work further, but this also may require investment in resources.

For 2022, members were asked to agree an increase in subscriptions of 2.5%, a temperate and reasonable decision given the conditions prevailing at the 2021 AGM. However, in the 12 months to December 2022 the Consumer Prices Index (CPI) rose by 10.5%.

This year we are asking for an increase in consultant subscriptions of 6.2% meaning there will still be a gap between inflationary pressures and the increase in subscriptions. We know that this is a tough ask in the midst of a cost of living crisis but this below-inflation increase will enable the College to continue to serve our members and demonstrate our value and purpose.

We have ensured the proposed increases are in-line with other Royal Colleges and as subscriptions remain a tax-deductible expense, the RCOphth hope you are able to support our request at the AGM, at Congress in May 2023.
